



Terms and Conditions

OPPIE TONG AF / ON THE TIP OF YOUR TONGUE is a nonprofit company offering a youth leadership and skills development programme in public speaking covering all nine provinces of South Africa.

1. Delivery policy

Once entries have been submitted and paid for online. **OPPIE TONG AF / ON THE TIP OF YOUR TONGUE** will process the entries and compile a schedule with the allocated time and date of performances per participant. The schedule will fall between the allocated dates as set out per event per province.

Schedules will be published on the events page no later than a week before the event will take place. A sms will be sent to the organiser or the person responsible for the entries with a unique access pin code. This pin code must be distributed by the organiser to all participants meaning that the schedule will be available to all participants. No divagation from the schedule will be tolerated.

Once the schedule is published on the website it will remain live until the event has been concluded. It remains the responsibility of the entrants to regularly view the schedule should changes to the performance time occur.

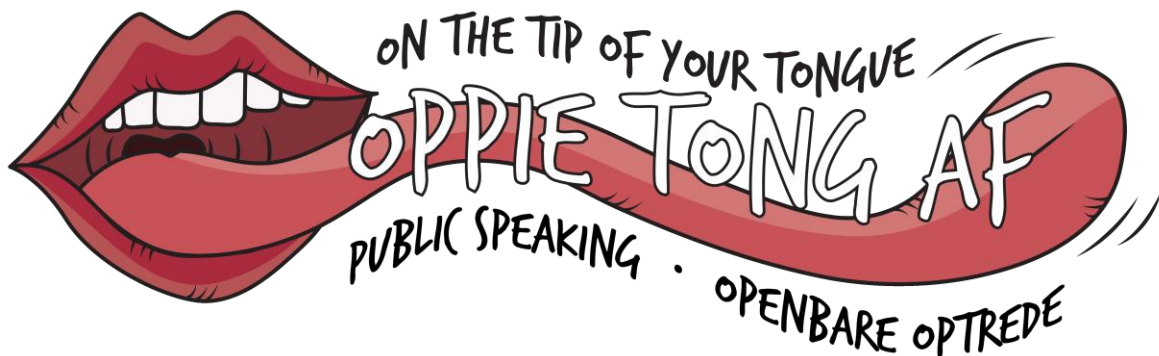
All modifications to the event schedule will **ONLY** be done by the **OPPIE TONG AF / ON THE TIP OF YOUR TONGUE** organisers.

Ensure that the participants are entered for the correct sections within the event.

Remember that groups consist out of **FOUR MEMBERS ONLY**.

2. Refunds policy

Fees paid for incorrect entries or entries not conforming to the **OPPIE TONG AF / ON THE TIP OF YOUR TONGUE** guidelines will under no circumstances be refunded but will be regarded as a donation towards the **OPPIE TONG AF / ON THE TIP OF YOUR TONGUE** youth leadership and skills development project in public speaking.



Participants that do not pitch for their performances on the scheduled date and time will under no circumstances be refunded.

3. Customer Privacy policy

OPPIE TONG AF / ON THE TIP OF YOUR TONGUE shall take all reasonable steps to protect the personal information of users. Payment may be made via Visa, MasterCard, or by bank transfer into the **OPPIE TONG AF / ON THE TIP OF YOUR TONGUE** bank account.

5. Card acquiring and security

Card transactions will be acquired for **OPPIE TONG AF / ON THE TIP OF YOUR TONGUE** via PayGate (Pty) Ltd who are the approved payment gateway for all South African Acquiring Banks. DPO PayGate uses the strictest form of encryption, namely Secure Socket Layer 3 (SSL3) and no Card details are stored on the website. Users may go to www.paygate.co.za to view their security certificate and security policy.

6. Customer details separate from card details

Customer details will be stored by **OPPIE TONG AF / ON THE TIP OF YOUR TONGUE** separately from card details which are entered by the client on DPO PayGate's secure site.

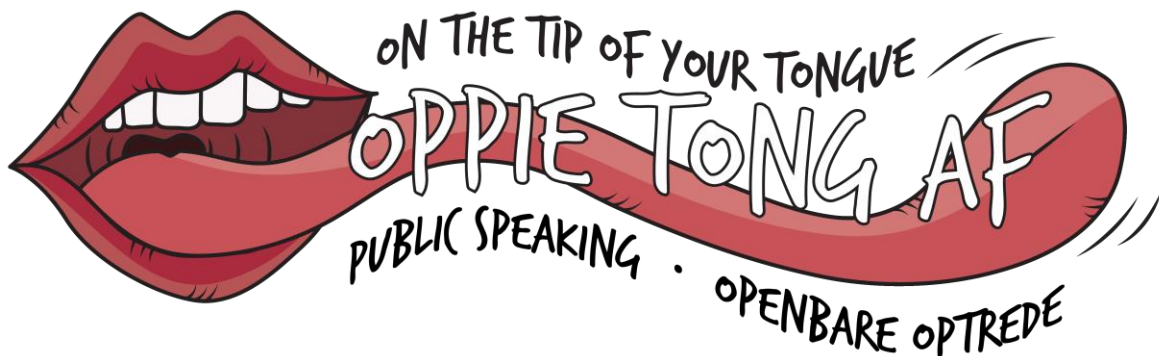
